### **Conference Overview**

The  $48^{th}$  Annual Texas Crime Prevention Association (TCPA) Conference will be held July 9-13, 2023, at the Hilton Dallas/Rockwall Lakefront in Rockwall, Texas. This event will bring together over 150 crime prevention experts and practitioners from the law enforcement, public sector, and private sector arenas throughout Texas. It will be a transformative networking and learning opportunity for everyone that attends. ### **About TCPA**

Created in 1976, the Texas Crime Prevention Association (TCPA) is a 501(c)3 nonprofit organization with membership comprised of law enforcement personnel, security professionals, loss prevention experts, community leaders, and involved citizens from across the state. TCPA is managed by a state board elected by membership and composed of nine affiliated but independent regions. Each region is governed by its own board of directors.

TCPA is a TCOLE-certified training entity dedicated to providing superior course offerings focused on proactive measures to stop crime before it occurs as well as Crime Prevention through Environmental Design (CPTED) strategies. ### **Target Audience**

TCPA conference attendees include executive, command, line-level and civilian personnel from law enforcement agencies; special investigative, non-profit, and community organizations; as well as personnel from businesses and entities concerned with the proactive prevention of crimes. ### **Exhibitor Shipping Guidelines**

If it is necessary to ship materials to the conference hotel, the following instructions apply:

- Each item must be clearly marked with:
  - o organization name
  - o organization planner
  - o name of event (TCPA Conference, July 9 13, 2023)
- Packages will not be accepted earlier than one business day prior to the event (July 7, 2023)
- The following shipping and receiving rates apply:
  - \$10 handling/per box: 0 49 lbs. (incoming and outgoing)
  - \$50 handling/per box: 50+ lbs. (incoming and outgoing)
  - \$125 handling/per pallet (incoming and outgoing)
  - \$5 storage fee per box or per pallet, per day
  - o \$25 per hour labor charge if hotel assistance needed to unload vehicles or move items
- The hotel must be advised of any items over 100 lbs. that will be displayed in any function area
- At conclusion of event, material must be return shipped immediately. A **\$50 per day** storage fee will be assessed for items remaining in the hotel's possession 48 hours after the conclusion of the event.
